A Green, Resilient, and Competitive Growth Model for the Eastern Partnership Countries



The **EU4Green Recovery East** programme is a regional initiative supporting the Eastern Partnership countries on their path towards a greener, more resilient, and competitive economy.

With an EU-contribution of EUR **21.3 million (2025-2028)**, this programme aligns with the European Green Deal and the EU's Global Gateway, driving forward environmental policy innovation that create jobs, improve health, and secure vital resources sustainably.



EU4Green Recovery East builds on the results of a decade of EU support for better water management and green economy adoption. Between 2021 and 2024, EU support enabled the adoption of **21 River Basin Management Plans, identified €7.7 billion in investment** needs, and promoted Nature-based Solutions.

It enhanced water quality monitoring, improved transboundary cooperation, and strengthened environmental data sharing. EU support also helped **400 SMEs** optimize resource use, introduced Eco-Industrial Parks for sustainable industry, and promoted eco-friendly product certification.

WHY EU4GREEN RECOVERY EAST?

*This programme is aligned with the shared commitment to a **sustainable and competitive future** for people in the Eastern Partnership countries, ensuring:*



Health & Well-being: Reducing water pollution and restoring degraded environment for healthier populations and resilient ecosystems.



Economic Growth & Jobs: Supporting businesses, particularly SMEs, to adopt sustainable practices that boost their productivity and foster local job creation. Facilitating access to EU markets by aligning environmental policies with EU standards.



Security & Stability: Reducing dependence on external resources through circular economy practices. Mitigating resource scarcity and environmental degradation with better management of natural resources. Encouraging dialogue between countries to find solutions to environmental issues.

RELATED INITIATIVES

This new programme is the successor to the green economy, water, and environmental data pillars of the regional EU4Environment programme. The protected areas and forestry pillar of EU4Environment has been extended and will continue until December 2026.

Other EU-funded programmes in the region on similar topics include the EU4Climate Resilience project which supports the green transition, decarbonisation, energy security, and climate resilience in the Eastern Partnership (EaP) countries.

FIVE PROGRAMME COMPONENTS FOR A GREENER FUTURE



1 Promote Circular Economy & Resource Efficiency. Helping businesses adopt circular models to create new jobs, reduce costs, and decrease reliance on imports.

2 Protect Water Resources & Reduce Pollution. Improving water quality through better management and monitoring to safeguard public and ecosystem health.

3 Align with EU Environmental Standards. Supporting governments in aligning with EU environmental policies (Chapter 27 of the EU acquis).

4 Strengthen Environmental Data & Digitalisation. Improving environmental data integration and sharing at country and EU level for better policy-making.

5 Enhance Transboundary Cooperation on Environmental Issues. Encouraging regional collaboration on natural resources to promote sustainable environmental policies and practices, addressing cross-border pollution.
